Introduction

The purpose of a neighborhood action plan is to identify issues that are of concern to the residents of the neighborhood, and to devise strategies for addressing these concerns. In conjunction with broader policies and implementation measures contained within the City's comprehensive plan, the neighborhood action planning process is intended to protect and enhance the livability within specific neighborhoods, as well as to help fulfill the overall community vision and to create a more livable city. More specifically, neighborhood action plans are intended to:

- Educate both city government and neighborhood residents about each other's concerns and visions for the future.
- Promote collaboration between the city and the neighborhood in order to achieve mutual goals and a shared sense of responsibility.
- Create a "sense of place" within the community by identifying and developing the assets within each neighborhood.
- Initiate change, rather than simply reacting to it, by addressing specific issues and opportunities.
- Achieve sensible and coordinated project and program planning within each neighborhood and between all the city's neighborhoods.
- Strengthen neighborhoods.



Relationship to the Comprehensive Plan

In general, a comprehensive plan is intended to provide broad policy direction, which is implemented through more specific development regulations and capital expenditure programs. Comprehensive plans do not, however, typically address the more immediate needs and concerns of individual neighborhoods. This is the purpose of a sub-area or neighborhood plan.

The City's comprehensive plan, entitled *Visions for the Vancouver Urban Area*, was adopted in December of 1994 and scheduled to be updated in 2002. The Plan specifically states that the City should: "*create neighborhood plans by assisting neighborhood organizations in identifying issues, policies and implementation measures specific to their areas.*"

The purpose of the Cascade Highlands Neighborhood Action Plan is to integrate neighborhood needs into the City's budget process, Six-Year Street Improvement Program, Neighborhood Traffic Control Program, Parks, Recreation, and Open Space Plan, and other planning and funding programs. The general policy statements included in the Action Plan may also be used by the City Council to guide future decisions involving development proposals and plan amendments affecting the neighborhood.



The Neighborhood Action Planning Process

The Cascade Highlands Neighborhood Association, with assistance from the City of Vancouver Office of Neighborhoods, has developed this plan. The actual preparation of this plan is being coordinated by the Neighborhood Action Planning Committee, whose members were appointed by the Neighborhood Association to represent the interests of the neighborhood as a whole.

A survey was taken and a draft version of this Action Plan has been made available to each household in Cascade Highlands for review and comment by all residents of the neighborhood. After considering and reconciling comments from the residents, the plan has been endorsed by the Neighborhood Association according to their specific by-laws. After neighborhood approval, the Plan will be forwarded to City Council for consideration and acceptance by resolution.

It is intended that city agencies will utilize the action plans as input in developing more specific work programs and helping to establish citywide funding priorities. It is recognized that many of the recommendations contained in the action plans are conceptual only and may need to be analyzed in greater detail, both individually and in relationship to other recommendations. It should also be emphasized that financial resources may not exist for implementing all of the recommendations identified in the plan.



Overview of the Plan

This Plan contains four components. The NEIGHBORHOOD PROFILE contains a general description of the current conditions within the neighborhood. The VISION STATEMENT describes the neighborhood's sense of identity and vision for its future. The NEIGHBORHOOD OBJECTIVES identifies issues that are of concern to the residents of the neighborhood. The NEIGHBORHOOD ACTION STEPS includes specific potential strategies for accomplishing the identified objectives. Each Action Step is prioritized and identifies the responsible parties for implementing those strategies.



Funding and Financial Resources

Having the Neighborhood Action Plan does not guarantee funding to carry out the Action Steps. The Vancouver City Council does appropriate grant money each year via Neighborhood Action Planning and matching grant programs to help implement Action Steps. In addition, neighborhoods may be eligible for many private, federal, and state funding programs.

Neighborhood Profile

Cascade Highlands N.A., one of the larger Vancouver neighborhood associations with a total population of approximately 3,500, is located between SE McGillivray and SE Mill Plain, and between SE Blairmont/Parkcrest and SE 164th Ave. It was recognized as the City of Vancouver's 51st neighborhood association on December 20th, 1999.

The area is a mix of large commercial enterprises (Albertsons, Hi-School Pharmacy, Health Experience Athletic Club, Regal Theaters Movie Theater, First Independent and Home Street Banks, etc.) restaurants and fast-food places, smaller businesses, a church, Homestead Park (located at 1800 SE 159th Place), auto repair/care, two mobile home parks, a nursing home, 1050 units of multi-family apartments, and 750 single-family rentals/resident-owner homes.

SE 164th and SE Mill Plain are two extremely busy and heavily traveled thoroughfares. Southeast Blairmont fronts Mountain View High School which, although not technically within our boundaries, affects the tenor and ambience of a significant portion of the neighborhood. It's noteworthy that from many places within this association, one can view both the dramatic Mt. St. Helens and the spectacular Mt. Hood.

The zoning in our neighborhood is primarily single and multi-family residential with some commercial and office-residential zoning in the northeastern corner. R-22 is multifamily residential (22 units per acre) OR-22 is office residential (22 office/residential units per acre) CC is Community Commercial, and R1-6 is single family residential (one unit per minimum lots size of 6,000 square feet).

Residents can readily hear PDX airplane activity, train horns warning at crossings just north of the Columbia River, and, currently, small aircraft traffic buzzing in the landing pattern for the soon-to-be-closed and developed Evergreen Airport.

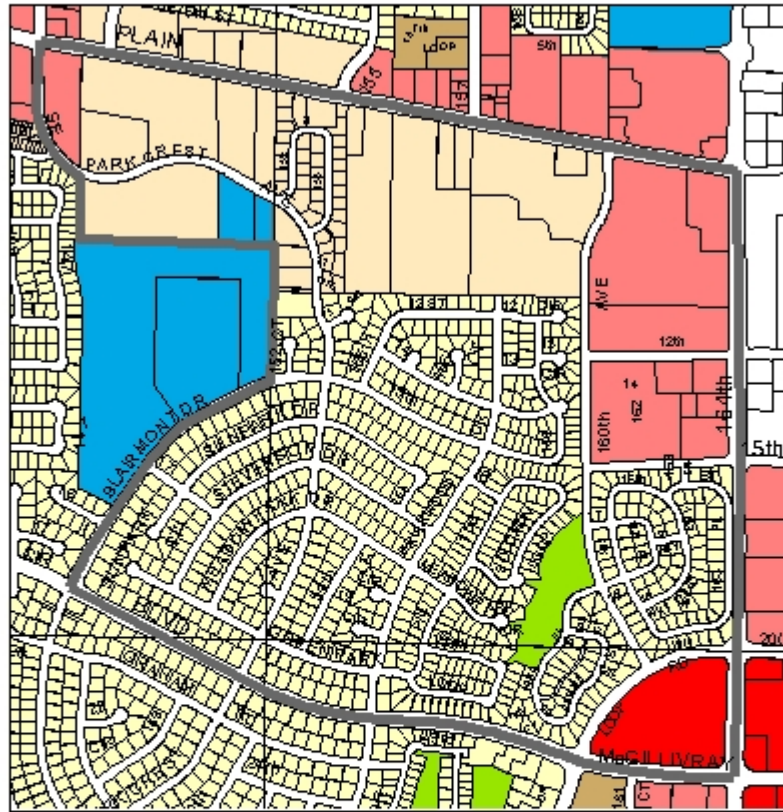
Cascade Highlands Neighborhood children attend Mill Plain or Crestline Elementary Schools, Wy'East or Shahala Middle Schools, and Mt. View High School.

C.H.N.A. is 375 acres located in Township 2 north, Range 2 east, Section 36 which places us directly in the middle of the traditional Mill Plain, historically a relatively flat and treeless area. That means that our 'soil' is composed of sand and gravel-sized deposits, along with larger and sometimes huge rocks left from the glacial outbursts from the ancient Lake Missoula which swirled around Camas' Prune Hill, 10,000 years ago.

Before about 1900 (but after the first settlements were established) the whole section was set aside as school land. Later, the area was sold off as "Mill Plain Homestead Lots" most of which were around 20 acres each.

The area just east of what is now SE Blairmont Drive was developed in 1979 and called Cascade Highlands. Next came Mountain View High School (1981), and Morningside (which is just north of McGillivray, in 1984): Then the apartments on Parkcrest (Trader's Green, 1986), Homestead Place (1988), Homestead Acres (1989), and Fisher's Mill Apartments (1991). There is still some commercially zoned property to be developed between SE 160th Ave. and SE 164th Ave. in the northeastern part of the association.

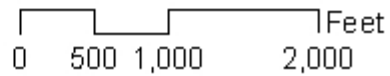
Neighborhood Zoning/Comp Map

Vision Statement

The Cascade Highlands Neighborhood Association is a vehicle and forum for effective two-way communication with the city. It establishes and maintains a structure for dealing with neighborhood issues as they arise.

We envision a neighborhood:

- Where residents are safe and feel secure;
- Where neighbors are willing to maintain their homes, yards, and property to the standards of the neighborhood;
- Where all residents' mobility is facilitated by sidewalks and streets which are free of hazards, are safe, and are completely accessible; and
- Where we partner with the City of Vancouver to maintain and enhance the neighborhood for the benefit of all.

Objectives and Action Steps

The following recommended action items identified as having a "high" priority are considered by the Neighborhood Association to be most important. "Medium" priority action steps are somewhat less important. "Low" priority action steps are considered least important.

Priority has been assigned by the Neighborhood Association for each action step without regard for the time

frame within which the recommendation can realistically be accomplished (short-range, long-range) and without concern for whether funding sources can be practically identified. Accordingly, it is possible that a "High" priority item may not be realized for many years. In contrast, some "Low" priority items could be potentially accomplished in a relatively short amount of time without significant capital expense.

I. MAINTENANCE AND APPEARANCE OF RESIDENCES AND COMMUNITY

Objective #1

To encourage neighbors to maintain their property and vehicle parking to the standards of the neighborhood which will help preserve and enhance neighborhood livability.

<u>Action Steps</u>	<u>Priority</u>	<u>Responsible Parties</u>
<ul style="list-style-type: none"> <p>▪ Divide into five areas the 648 total 4' x 8' fence panels which need painting within our neighborhood boundaries. These panels face the north side of Village Loop, both sides of SE 160th Ave. north of Village Loop, the south side of 15th St. (east of 160th), and the north side of McGillivray between Village Loop and Briarwood. Some paint will be donated by Clark County Solid Waste, but most will be obtained from the Metro Paint program.</p> <p>The five phases will consist of four steps each: clearing the duff from the ground and trimming the bushes to gain access to the fence, and, to each panel, applying an anti-mildew solution (where necessary), washing using a pressure washer, applying off-white paint, and lastly, highlighting the supporting posts using gray paint.</p> 	High	CHNA, CCSW, CITY

Encourage planting of trees within city rights-of-way to enhance community appearance, increase the tree cover rate/urban forest percentage, and promote slower driving speeds.
