**ZONING REVIEW SUBMITTAL REQUIREMENTS (USE Com'I New Application)
 For Collocation On An Existing Support Structure Or Locating On Existing
 Buildings or Structures**

A. **Fees** Any fees associated with the application.

Provide 3 copies, collated and folded, containing all of the information required below. Plans larger than 24" x 36" will not be accepted. Plans larger than 8 1/2" x 11" must be folded.

- B. **Application Form** Submit a completed application. If someone other than the owner is signing application, an authority to act letter from the legal owner is required.
- C. **Narrative** Include a narrative describing compliance with the General Development Standards of VMC 20.890.040.
- D. **For collocation**, two (2) copies of the site plan showing additions to the existing wireless communications facility and location of equipment structures.
- E. **For locating on existing buildings or structures**, two (2) copies of a site plan showing the proposed location of the antennas, location of equipment structures and setback dimensions from the antennas and equipment structures to abutting lot lines.
- F. 1/4 -section vicinity map showing the street location.
- G. Electrical plans, including service location, load calculations and single line distribution.
- H. Building construction plans of the antennas, location and method of attaching the antennas and accessory structures, including cross sections, elevations, and structural calculations.
- I. Other. Include in application information all the appropriate associated plan approval numbers/permits issued by Clark County or City of Vancouver.
- J. A valid agreement for collocation on the existing support structure or a valid agreement to locate on an existing building or structure.
- K. A graphic simulation of the proposed facility from at least three perspectives, one of which shall be from the ground level from any abutting residential property or the nearest public right-of-way.
- L. A map of the service area and a written explanation of the need for the facility.

Prior to the issuance of a permit, the following shall be submitted:

- M. A copy of the applicant's FCC license.
- N. A copy of liability insurance covering the facility being applied for.
- O. A copy of a performance bond in conformity with VMC 20.890.040.N
- P. A copy of any lease agreement showing that it does not preclude the site owner from entering into leases of the site with other service providers.
