A zoning verification letter is a document provided by the City to verify the current zoning of a site with a summary of the allowable uses within the zoning classification.</p> <p>What type of information is provided in a zoning verification letter? The zoning verification letter provided will contain the following information:</p> <ul style="list-style-type: none"> The zoning district and zoning overlay districts applied to the property. If the use of the subject property is legal/nonconforming/or legal nonconforming. If there are any outstanding code enforcement violations on the property. Provisions set forth for rebuilding the structure if destroyed. <p>The zoning verification letter is provided in a standard format approved by the City of Vancouver. This is the <u>only</u> format in which this information will be provided. Please do not submit sample letters with desired format or content, as they will not be provided.</p> <p>How do I obtain a Zoning Verification letter? Complete the form on the reverse side of this page and submit with the required application fee of \$137.67 per parcel.</p>	<p>What is a Zoning Certificate? A zoning certificate is a document provided by the city that covers the information provided in a zoning verification letter as well as the process and review the project went through prior to construction or renovation.</p> <p>What type of information is provided in a zoning Certificate? The zoning certificate provided will contain the information provided in the zoning verification letter as well:</p> <ul style="list-style-type: none"> Historical zoning of the property Compliance with Parking standards Compliance with Setbacks If the project is located within any known Critical Areas. Information on whether the project was built as a planned unit development or under the site plan review process. <p>The Zoning certificate is provided in a standard format approved by the City of Vancouver. This is the <u>only</u> format in which this information will be provided. Please do not submit sample letters with desired format as they will not be provided. We will, however, accept supplemental letters providing information on the project that will allow us to conduct a more extensive study.</p> <p>How do I obtain a Zoning Certification?
