Parking Permit Application

Please provide all information requested. Incomplete or illegible application forms may not be processed. Permits must be purchased in person, but may be renewed online.

Parking permits not renewed by the expiration date will be subject to citation, deactivated and the permit may be released to another customer.

Food Truck Permits

Permit approval is contingent upon approval and participation in the On-Street Mobile Food Vending Pilot Project.

Qualifying businesses may purchase a permit to use at any one of the parallel metered spaces in Zone 3 or 4 as approved in their Street Use Permit. If one vehicle is unable to be parked entirely within the painted stall lines of a single parking stall, an additional space must be purchased. A maximum of 3 adjacent spaces may be used by one business.

Permit holder accepts responsibility to abide by all Parking Services On-Street Terms & Conditions and Rules & Regulations.

Permits must be displayed as required. Failure to display permit(s) may result in citation(s).

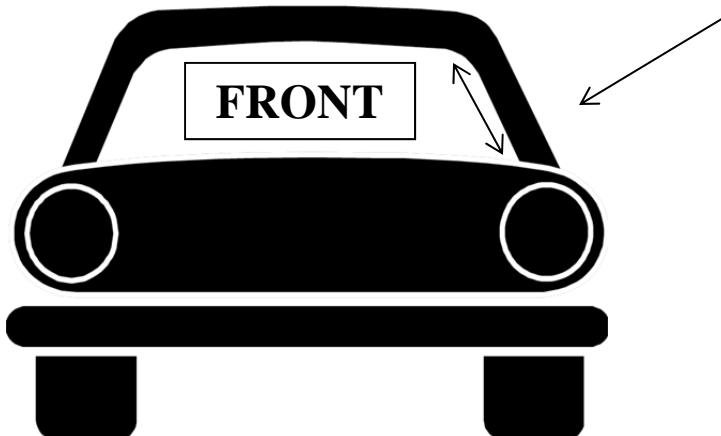

SECTION 3 FOOD TRUCK PARKING AGREEMENT

I understand by completing this form, I am applying for a parking permit. This application form does not constitute any agreement for parking services until this application is processed by the City of Vancouver and a parking permit is issued. I agree to the terms and conditions of use for the type of parking permit and payment method I have selected. **I understand that I must renew the permit prior to expiration, according to the City of Vancouver's Terms and Conditions and Parking Rules and Responsibilities. Failure to do so will result in citation(s) being issued, and I may forfeit my right to my parking space.** I understand I must display my parking permit on the inside of the driver's side of the windshield of my vehicle, completely in view, but not to obstruct the driver's clear view of the road, per RCW 46.37.410. I understand misuse of any parking permit may result in a citation for improper parking and infractions may result in suspension of any parking permit. I understand rates may change over time. I have received, understand and shall comply with the City of Vancouver's Parking Terms and Conditions and Parking Rules and Responsibilities. I understand that the Terms and Conditions and Rules and Regulations are subject to change without prior notice, and if I don't agree to the changes I shall notify the City of Vancouver and forfeit my parking privileges. **I understand that this is a pilot program which the City of Vancouver may discontinue at any time at its sole discretion.** I certify the information provided on this form is true and accurate to the best of my knowledge.
