July 13, 2023

ITEM 1: CALL TO ORDER

The July 13, 2023, meeting of the Culture, Arts and Heritage Commission (CAHC) was called to order at 12:03 p.m. by CAHC Chair Linda Reid in Aspen Community Room at Vancouver City Hall and via Microsoft Teams. Mercado entered at 12:25 p.m.

ITEM 2: APPROVAL OF MINUTES

Motion by C.A. Richardson, seconded by Harrington, and approved unanimously to adopt the minutes from June 8, 2023 as presented. Gall abstained.

ITEM 4: AD HOC COMMITTEE FOR COMMISSION APPLICATION REVIEW

The Commission requested to delay their recommendation from the subcommittee until provided with more information about the candidates.

ITEM 6: CULTURAL SERVICES REPORT

Donovan gave an update on the Vancouver Arts and Music Festival and highlighted volunteer opportunities for the Commission.

ITEM 3: CULTURE, ARTS & HERITAGE GRANT AWARD DECISION

General Discussion

Reid asked how the Commission felt about funding multiple proposals from the same organization. CA Richardson stated that she had no issue with it because staff permitted it at the grant workshops. Reid stated that a diversity of project types was important to her. CA Richardson added that the ability to provide partial funding to proposals made the evaluation process easier.

Deliberation

The Commission discussed each proposal and arrived at a recommended funding package as follows:

The total recommended funding was less than the funding available. CA Richardson asked if the remaining amount could fund interim use of the Vancouver Arts Hub building. The Commission supported the suggestion, but declined to reference it in their motion as the timing of interim use is uncertain.

Motion by Reid, seconded by Gall, and approved unanimously to award the Culture, Arts & Heritage Grant funds as distributed in the above table.

Additional Discussion

The Commission had several suggestions to improve the next round in 2024 and requested a follow up meeting to work through new ideas. Issues identified included:

Application changes:

- Start the application with an "Organization Mission" question
- Fix budget form to be more user and reader friendly, including instructions
- Add "Are you an individual artist who needs a non-profit fiscal sponsor? contact us" to the materials and/or application

Process suggestions:

- Provide example of successful application
- Add staff review period and offer applications an opportunity to clarify/revise
- Provide workshop on data tracking, project updates, and submitting reimbursements

Policy Questions:

- What is the right balance between creating projects vs sustaining organizations?
- How can the commission foster ongoing relationships with artists? How can they provide business development?
- How should historical information be vetted before it is incorporated into art & culture projects?

ITEM 7: PRESIDENT'S REPORT

Reid provided the following updates:

- VDA will unveil Volunteer Corner during the RevitalizeWA Conference in early October.
- Reid attended the ArtsWA Creative Arts District conference in Port Townsend. Vancouver already has many features of an Arts District, but an official designation will open new state funding.
- Reid met with InspireWA to discuss establishing a Cultural Access Fund for the region. If successful, it would equate to \$6M in funding. Reid feels the timing is right to advance a proposal to the County and City.
