AMENDMENT #1

INTERLOCAL AGREEMENT
AMONG CLARK COUNTY, THE CITY OF VANCOUVER, EVERGREEN PUBLIC
SCHOOLS, AND VANCOUVER PUBLIC SCHOOLS

SAFE COMMUNITIES TASK FORCE

WHEREAS the parties entered into an Interlocal Agreement effective January 1, 2016 to fund the Clark County Safe Communities Task Force to coordinate a number of youth gang crime and violence prevention programs; and

WHEREAS the Interlocal Agreement includes a 2-year extension option; and

WHEREAS the parties desire to exercise that extension option to provide continued funding for the Clark County Safe Communities Task Force;

NOW, THEREFORE, the PARTIES agree as follows:

1. The term of this Agreement is extended to December 31, 2020.
2. During the extended term of this Agreement, the County shall contribute a minimum of \$100,000 annually. The other parties shall provide Clark County **annual funding** in the following amounts:
 - 2.1. The City of Vancouver shall pay Clark County \$50,000.
 - 2.2. Evergreen Public Schools shall pay Clark County a minimum of \$25,000.
 - 2.3. Vancouver Public Schools shall pay Clark County a minimum of \$25,000.
3. This Amendment shall be executed in multiple copies, each of which shall be valid as an original. The parties agree that there shall be four (4) duplicated originals of this Amendment with multiple original signature pages distributed for signature by the necessary officials of the respective parties. Upon execution, one executed original of this Amendment shall be retained by each of the parties. The City of Vancouver and Clark County will post a copy of this Amendment on their respective websites pursuant to Chapter 39, Laws of Washington 2006 (RCW 39.34.040). Upon execution of the originals and the postings on the City and County websites, each such duplicate original shall constitute an extension of the agreement binding upon all parties.
4. All other terms and conditions of the original Agreement, as amended, remain the same.
