

Vancouver Mall Safe Parking Zone Program Code of Conduct

The Safe Parking Zone program is intended to provide a safe and organized space for individuals who are experiencing homelessness to park in their vehicles on a temporary basis and practice social distancing during the COVID - 19 health emergency. The program is for individuals with operational motor vehicles only.

The program will run during the Washington State "Stay Home, Stay Healthy" order. Participants will be given minimum of 12 hours' notice to vacate after the order is lifted.

This Code of Conduct is intended to ensure the safety and security of all safe park participants and staff, as well as ensure the maintenance of the area.

CHECK-IN: You are required to check in to receive an assigned spot and participate in the program. Failure to check in or unauthorized participation will result in suspension from the program. The program is limited to 2 adults per vehicle. Families with children are welcome and all children must be listed below. No other participants may be added initial after check in.

PARKING ASSIGNMENT: Each participant will be assigned a parking space along with a parking pass; your vehicle must be in this space with the parking pass hung from the mirror and visible.

SOCIAL DISTANCING AND PERSONAL HYGIENE: Each participant must follow social distancing and hygiene procedures as recommended by the State of Washington in response to the COVID-19 health emergency. This includes remaining at least 6 feet from participants in other vehicles, frequent hand washing, no sharing of food or drink, appropriate disposal of trash, etc. You must wear clothing and shoes at all times outside your vehicle.

LEAVING THE SITE: You are permitted to leave the site only for essential trips including acquiring food or health care consistent with the State of Washington "Stay Home, Stay Healthy" order. These trips should occur between 6am and 8pm only. Contact security if you need to leave outside of these times for an emergency. When away from the site, you are still expected to practice social distancing and strong personal hygiene. Non-essential trips are cause for suspension from the program.

NO VISITORS: No visitors will be allowed at any time due to the need for social distancing.

MAINTENANCE OF SITE: You must keep all of your possessions in your vehicle unless you are briefly organizing or packing. You may be outside your vehicle in the area of your parking space but you may not set up tents or canopies. All garbage must be disposed of promptly in the trash receptacles provided.

BATHROOMS: Bathrooms are to be used for personal hygiene purposes only. Limit your time to what is essential for your needs so that bathrooms are available for other participants. You must use hand sanitizer and hand washing station after every use.

ALCOHOL, DRUGS: The sale, purchase, or use of drugs or alcohol is not allowed anywhere on the site.



SMOKING: For public health reasons, smoking is only allowed in your vehicle. Cigarette butts and garbage must be properly disposed of and not left on the ground.

PETS: Pets are allowed but must be in your vehicle or leashed/contained and under your control at all times. It is your responsibility to properly dispose of your pet waste.

PROHIBITED BEHAVIORS: The following behaviors will not be tolerated at any time - arguing; threats or acts of violence; physical fighting; acts or language which constitute racism, anti-Semitism, sexism or homophobia; theft; brandishing weapons; harassment. A single violation of any of these types of behaviors will result in suspension from the program.

CAMERAS: Video cameras will be used to monitor the site to support safety and security. Your signature here indicates that you consent to having video cameras at the site.
