What can I do with the MyVancouver app?

**** Report non-emergency issues, such as potholes, graffiti, sign damage or streetlight outages quickly and easily. Include a photo and GPS location.

**** View and track the status of a request or view other reported issues in a particular area of the city.

**** Access other online City services, such as paying for parking ticket, permit payments.

**** Access other City information, including street sweeping schedules, a community event calendar and City job listings.

**** Easily locate local parks, hospitals, community centers and more.

**** Connect with the City’s social media with an #IHeartVanWa widget.

Can customers still submit requests online through the web portal?

Yes. The mobile app doesn’t replace any current methods (e.g. phone, web, etc.) that customers use to report issues, it just provides a new method. With the new app, you can also report issues using the web interface above.

How to Report Crime in the City of Vancouver

The Vancouver Police Department does not currently offer online reporting.

These crimes may be reported via 3-1-1 or through our precincts:

- Graffiti or Tagging (damage less than \$750.00)
- Harassing Phone Call
- Identity Theft or Fraud
- Lost Property
- Malicious Mischief (damage less than \$750.00)
- Theft (amount of theft less than \$750.00)
- Vehicle Prowl
- Vehicle Prowl – Motor Home

Graffiti Clean Up

If left alone, graffiti will attract more of the same. It creates a perception that the area is unsafe. To curb the spread of graffiti it is important for all of us to address it as soon as it is observed. How can you help?

1. Record —Take a picture, document the date, time, location, and color of the graffiti
2. Report—Provide details to the appropriate agency
3. Remove from your property — once notified, wash or paint away quickly & thoroughly.

ACCEPTED

Any medications in any dosage form in an original container or sealed bag.



NOT ACCEPTED

Herbal remedies, vitamins, supplements, cosmetics, personal care products, medical devices, batteries, mercury-containing thermometers, sharps, illicit drugs, and pet pesticide products.



MEDICINE KIOSKS

Located at pharmacies and law enforcement offices for residents to drop-off expired or unwanted medicine for safe and free disposal.

Follow these healthful tips to keep your medicines safe and loved ones free from harm.



SAFE MEDICINE STORAGE TIPS



- At home and on-the-go, store medicine safely in a locked location away from people and pets. Learn more at LocksSaveLives.org.
- Resist the urge to keep medicine handy by returning it to a locked location after each use.
- Use child-resistant caps and close the caps tightly after each use.
- Don't share prescription medication with others as it's illegal and may cause them harm.
- Keep inventory of medicines to know how many pills are left and if any are missing.

PROPER MEDICINE DISPOSAL TIPS



- Dispose of all unused and expired medicine immediately and properly.
- Do not place medicine in the trash or recycling, and never flush it down the toilet or drain as it pollutes the environment and waterways or could be misused by someone for whom it wasn't prescribed.
- Properly dispose of expired and unwanted medicine by dropping it off at a drug take-back event, a year-round disposal site, or dispose of it by mail. Learn more at MED-Project.org or bit.ly/DEATake-Back.
