- Branches, twigs, tree pruning (up to 4" in diameter)
- Tree Limbs (up to 4" in diameter)
- Trunks
- Woody debris does not need to be dried prior to chipping.

<u>Please NO</u>

- Juniper, arborvitaes, ivy, vines, bamboo and blackberry briar get tangled in machinery.
- Leaves, grass clippings
- Pine needles
- Rocks, dirt, large stumps
- Painted or treated wood

Marijuana is legal but do you know the law?

(from the City of Vancouver website)

Can I consume Marijuana in public places such as parks or in my vehicle?

No! Washington State law, or Revised Code of Washington, RCW 69.50.445 states: **It is unlawful to open a package containing marijuana, useable marijuana, or a marijuana-infused product, or consume marijuana, useable marijuana, or a marijuana-infused product, in view of the general public. A person who violates this section is guilty of a class 3 civil infraction under chapter 7.80 RCW.**

The penalty for opening a package of or consuming marijuana, useable marijuana, or marijuana-infused product in view of general public is a civil fine of \$103.

Crossing the Washington State line:

Washington laws on possession and consumption of marijuana differ from the laws of other states (including Oregon). Anyone buying marijuana in Washington should understand the laws of the state you are traveling to before crossing the state line. Failure to do so could result in criminal action being taken against you.

Remind me of the legal possession amounts?

- The law allows a person 21 or older to have up to 1 ounce of useable marijuana OR up to 16 ounces of marijuana-infused product OR up to seventy-two ounces of marijuana-infused product in liquid form. (i.e., you may NOT possess the maximum amount of marijuana in two or more forms at any one time.)
- Possession of more than 28 grams, but less than 40 grams is still a misdemeanor.
- Possession of 40 grams of marijuana is still a felony.

What does the new law mean for law enforcement?

- I-502 changes very little for law enforcement, it merely de-criminalizes possession of limited amounts of marijuana. Consumption and opening a package of marijuana in public are civil infractions.
- It is still illegal for persons under 21 years of age to possess or consume any amount of marijuana or marijuana-infused products.
- Driving under the influence of marijuana or under the combined influence of marijuana and anything else, such as alcohol, is illegal and law enforcement agencies continue to strictly enforce DUI laws.

<u>Understanding HOAs – Love them or hate them; most misunderstand them.</u>

Inside the Fircrest Neighborhood, there are several Homeowners Association (HOAs). Did you know . . .

Using an HOA's private areas is essentially the same as entering the backyard of a private home uninvited. It's trespassing.

Homeowners pay for the upkeep and maintenance of shared common areas.

Homeowners agree to follow a shared set of rules.

HOAs often have shared property or "common areas." This means every homeowner shares ownership as well as maintenance and fiscal responsibility for these features, including upkeep, repairs, taxes, etc. To support these areas and keep them looking good and working properly, homeowners pay monthly HOA dues on top of what they might be paying for their mortgage. Some HOAs even pay for their own street maintenance and re-paving!

Those of us not living in an HOA, but adjacent to one that is not gated, should keep to public streets within the community and take care to be a good neighbor and not intrude in an association's private common areas, including green space, yards, play areas, dog parks, and parking spaces.

WHO YA GONNA CALL? by Mike A

At 3 in the afternoon suddenly everything is shaking, or a huge windstorm hits causing many trees to go down throughout the city. Roads are blocked; the I-5 bridge is stuck open. Car accidents block the I-205 Bridge; you are at work; kids are at school or on their way home. How are you going to get hold of your family? 500,000 cell phones suddenly start calling, but the cell system is overwhelmed. What now?



Here's something many don't know. If you text to a number outside of our region, it most likely will go through. Texting California, Idaho, Utah or other states can be the way to get hold of your family, by using someone there to relay messages. Part of your emergency plan should be to identify an out-of-region contact to be your communications hub. Everyone in your family should have their cell phone number, and they should have all of yours.

Example: An earthquake hits; you text "Aunt Kathy" in California, letting her know what has happened and to try to reach your family, letting them know where you are. Or your kids and spouse, separated, contact her to let you know where they are and if they are safe. Aunt Kathy becomes the relay for messages back and forth, where to rendezvous and plans on where you can stay if you can't get home.

This one step in your Emergency Plan will keep you informed, reduce anxiety, and help you plan next steps. Remember, in this type of emergency for the first 3-5 days, Emergency Services will be overwhelmed, and Public Works will be busy trying to clear roads and get power and water working. You need to have a plan to take care of your family without their help. Communication within the family will be critical. **Plan for it now.**
