Proposal: Review Draft 3 of the 2024-2029 Transportation Improvement Program

(TIP)

Recommendation:

This is the second workshop with the Transportation and Mobility Commission (TMC) for the annual updates to the Transportation Improvement Program (TIP). On November 1, 2022, staff introduced some of the proposed updates for the 2024-2029 TIP to the TMC. Staff has incorporated the comments from the TMC (as well as others) since the November workshop and we are now on the 3rd draft of the TIP (Attachment A). This workshop is intended to review the 3rd draft of the TIP with the TMC and identify any additional questions, clarifications or refinements that need to be addressed in the final draft. At a May 2, 2023 public hearing, staff will ask the TMC to forward a recommendation to City Council supporting adoption of the 2024-2029 TIP.

I. PRIOR COMMISSION REVIEW (IF APPLICABLE):

a. November 1, 2022 workshop with TMC.

II. BACKGROUND AND REVIEW PROCESS:

- a. State law requires the City of Vancouver to annually update its Transportation Improvement Program (TIP), which lists future transportation investments and level of committed funding and is required to be adopted by July 1 of each year.
- b. The Transportation and Mobility Commission enabling ordinance outlines the Commissions scope of authority and includes a recommendation to Council on adoption of the annual TIP update.
- c. A City Council will review of the 2024-2029 TIP in June, 2023.

III. SUMMARY OF ISSUE/ PROPOSAL:

- a. Updated lists of funded, partially funded, unfunded, and programs for review.
- b. Continue with interim project prioritization process.
- c. Updates to the arterial map for review.
- d. Review public comments since last update.

IV. RECOMMENDED ACTION:

a. TMC to ask any remaining questions and put forward additional changes or recommendations for the 2024-2029 TIP, which will be reviewed and implemented through the development of the final draft of the TIP document and presented for TMC consideration at a public hearing on May 2, 2023.
