**SUBJECT:** Request for the Urban Forestry Commission to approve or deny the nominated list of trees to be designated with Heritage Tree status.

**PROPERTY LOCATIONS:** Multiple locations (See Exhibit 1)

**NEIGHBORHOOD ASSOCIATIONS:** Carter Park, Esther Short, Fircrest, Forest Ridge, Hough, Lincoln, Old Evergreen Highway, and Wildwood

**RECOMMENDATION:** Subject to testimony received, Staff recommends that the Commission **APPROVE** seven of the nine trees or groves as Heritage Trees.

## **I. APPLICANTS REQUEST:**

Request for the Urban Forestry Commission to approve the nominated trees for Heritage Tree status.

## **II. APPLICABLE REGULATIONS:**

### **A. Zoning Ordinance (VMC Title 20) Section 20.770 Tree Conservation**

## **III ANALYSIS AND FINDINGS:**

According to VMC 20.770.120, an inventory of significant trees shall be developed and be so designated as heritage in status based on the set criteria in the code. The process in which these trees are identified are as follows:

- 1. The City shall develop an inventory of Heritage Trees that shall satisfy the criteria of this of section. The initial inventory shall be the responsibility of the Urban Forestry Commission as established under VMC 12.02 and shall be updated annually by the Commission. The City Council, Planning Commission, Urban Forestry Commission, Neighborhood Association, a property owner, or any person may recommend to the City that a tree be designated a Heritage Tree.*
- 2. The Heritage Tree designation may be applied to a tree or grove of trees.*

The Urban Forestry Commission has received nine complete nominations for trees or groves within the City of Vancouver. Each nomination was evaluated for the following:

1. Whether the tree or grove is in healthy growing condition;
2. Whether the tree or grove meets any one or more of the criteria set in VMC 20.770.120.B or not; and
3. Whether the nominator received permission from the tree owner to seek heritage status for the tree/grove or not.

Not all nominations succeeded in all determinations as described in the technical review. The nominations are either on public property (parks and right-of-way) or private property, with the appropriate property owner agreements signed.

Pursuant to VMC 20.770.120, the Staff is holding one public hearing before the Urban Forestry Commission on the proposed designations. Pursuant to the code, each tree owner has been notified of the nomination and public hearing with the Urban Forestry Commission within the set time period of at least 30 calendar days prior to hearing. Staff has received one comment on the designations. However, according to VMC 20.770.120.A3, if an owner of the property on which any of the trees is situated, objects to such designation *in writing to the Urban Forestry Commission prior to the public hearing or at the public hearing*, the designation procedure shall not proceed for that objected tree.

The Urban Forestry Commission establishes the list of Heritage Trees based on the criteria found in VMC 20.770.120 and are as follows:

***B. Criteria.*** *For any individual tree or grove of trees to be listed as a Heritage Tree(s), it must be in an apparently healthy growing condition and one or more of the following exist:*

1. *The tree has a dbh of 36 inches or greater; or*
2. *The tree is included in the City of Vancouver Heritage Tree Inventory as established by the Urban Forestry Commission based on one or more of the following criteria:*
  - a. *The tree has a distinctive size, shape, or location, or is of a distinctive species or age which warrants a Heritage Tree status; or*
  - b. *The tree possesses exceptional beauty which warrants a Heritage Tree status; or*
  - c. *The tree is distinctive due to a functional or aesthetic relationship to a natural resource, such as trees located along stream banks or trees located along ridge lines; or*
  - d. *The tree has a documented association with a historical figure, property, or significant historical event.*
3. *A grove may be considered for Heritage Grove Status if it is apparently in a healthy growing condition and one or more of the following criteria:*
  - a. *The grove is relatively mature and is of a rare or unusual nature containing trees that are distinctive either due to size, shape, species or age; or*
  - b. *The grove is distinctive due to a functional or aesthetic relationship to a natural resource, such as trees located along stream banks, or trees located along ridge lines; or*
  - c. *The grove has documented association with a historical figure, property, or significant historical event.*

## **Regulations with Heritage Tree Designation**

When a tree is designated a Heritage Tree, any development that will affect the tree will be required to go through a development review process as outlined in VMC 20.770.120.C.

### **C. Heritage trees development review**

1. *When development is proposed for property which contains a heritage tree, and the Planning Official determines that the proposed development may affect a heritage tree, the property owner must have a tree preservation plan prepared by a qualified arborist demonstrating how the heritage tree will be protected and preserved. A heritage tree shall be preserved unless the Urban Forestry Commission determines that the tree may be removed based on the criteria for heritage tree removal found in Subsection (D)(1) below.*
2. *A tree preservation plan shall be composed of the following:*
  - a. *A site plan indicating the location of heritage trees.*
  - b. *The methods to be used to preserve the heritage trees.*
  - c. *If a heritage tree is proposed for removal, a narrative statement outlining the reasons why the heritage tree should be removed from the inventory.*
  - d. *A mitigation plan indicating the replacement trees or additional new trees to be placed on the site. The mitigation plan should demonstrate, to the extent possible, that the character of the site will not substantially change as the result of development.*
3. *Site design adjustments may be allowed in some cases, as follows:*
  - a. *The Planning Official may grant a variance to front, side, and/or rear yard setback standards by up to 20% to retain a heritage tree(s). The adjustment shall be the minimum necessary to accomplish preservation of trees on site and shall not conflict with the City Adopted Building Code or other adopted ordinances or conditions placed on the property.*
  - b. *The Planning Official may grant a 10% variance to the lot size and/or a ten percent variance to*

*the lot width and/or lot depth standards in approving a short plat or other land division if necessary to retain heritage trees. The Planning Official may accept a preliminary plat application and recommend approval to the hearing body of a plat that provides for similar variance to lot size, width and depth standards if necessary to retain heritage trees.*

As a Heritage Tree, the process in which the tree is maintained or designated for removal is as follows:

*D. Removal of a heritage tree*

- 1. Except for the provisions in Section 20.770.030 VMC, no person may cut or remove a heritage tree without obtaining approval from the Urban Forestry Commission. The tree removal permit shall be approved if one of the criteria is satisfied:
  - a. Retention of the tree would make reasonable use of the property allowed under the current zoning impractical or impossible in that the development would not be allowed to meet the maximum density allowed by the applicable zoning.*
  - b. The removal is necessary to accommodate a new improvement, structure or remodeled structure, and no alternative exists for relocation of the improvement on the site, or that variances to setback provisions of this Title will not allow the tree to be saved or will cause other undesirable circumstances on the site or adjacent properties.*
  - c. The tree is hazardous, diseased or storm damaged and poses a threat to the health, safety or welfare of the public.*
  - d. The tree has lost its importance as a heritage tree due to damage from natural or accidental causes, or is no longer of historic or natural significance.*
  - e. The tree needs to be removed to accomplish a public purpose and no practical alternative exists.**
- 2. The limb structure, or crown, of a heritage tree may be pruned in any one-year period without obtaining approval from the Urban Forestry Commission, provided that at least 80% of the existing tree crown remains undisturbed.*
- 3. Any person who wishes to prune a heritage tree in excess of 20% of the existing crown shall obtain approval from the Urban Forestry Commission subject to the following conditions:
  - a. The protected tree shall be pruned following acceptable arboricultural standards.*
  - b. The tree shall be pruned in a manner that ensures safety to public and private property and shall be done by a qualified arborist.*
  - c. Any other conditions necessary to ensure compliance with the requirements of the community development plan.**

#### **IV. CONCLUSION**

Based upon the information submitted by the nominations and the staff findings presented in this report, staff concludes that seven of the trees or groves that were nominated for Heritage Tree status are deemed worthy of such recognition.

## **V. RECOMMENDATION**

In recognition of the findings and conclusions contained herein and incorporating reports of affected agencies and exhibits received in the matter, staff hereby recommends that the Urban Forestry Commission approve seven trees or groves of the nine trees or groves nominated to continue the establishment of Vancouver's Heritage Tree Program.

## **URBAN FORESTRY COMMISSION DECISION**

This report to the Urban Forestry Commission is a recommendation from the Community Development Department and Urban Forestry staff. The Commission may adopt, modify or reject this recommendation. The Commission will render a decision at the hearing or within 10 working days of the hearing. Decisions of the Commission are appealable to the City Council within fourteen (14) calendar days from the date of the Commission's decision. Appeals shall comply with the requirements of VMC 20.210.130 and shall be made in writing to the Community Development Department Manager, PO Box 1995, Vancouver, WA 98668-1995. An appeal fee in the amount of \$2,286.00 made payable to City of Vancouver must accompany the appeal. However, if the aggrieved party is a recognized neighborhood association and the neighborhood association votes to appeal the decision in accordance with their adopted bylaws, the applicable appeal fee is \$173.00.

Criteria Review – Significance of the trees

The tree is a street tree located between the curb and sidewalk. It is providing shade at this corner. The tree is not of significant size, shape or location nor any documented history.

Criteria Review – Condition of the trees

The tree is in good condition. 1000 Canker Disease is impacting Black Walnuts in the region however this specimen does not appear to have the disease.

Maintenance Requirement

No maintenance is needed at this time.

**Recommendation:** Deny the Black Walnut tree as a Heritage Tree as the tree is not a distinctive size (greater than 36 inches in diameter), shape, location, or of a distinctive species or age which warrants a Heritage Tree status

**Recommendation:** Approve the Giant Sequoia as a Heritage Tree due to size and history.

Criteria Review – Significance of the trees

The trees are street trees providing significant shade to the parking lot and street. There is sidewalk damage but can be corrected with modifications. Reviewing historic aerials photos, the trees were likely planted in the 1980's with street improvements. The City of Vancouver does not support moving these trees forward as Heritage Tree as they may be impacted by the new I-5 Bridge Project.

Criteria Review – Condition of the trees

The trees are in good condition.

Maintenance Requirement

Crown clean and prune for structure. Sidewalk needs to be repaired in the future.

**Recommendation:** Deny the 3 Northern Red Oaks trees as Heritage Trees as they are not a distinctive size (greater than 36 inches in diameter), shape, location, or of a distinctive species or age which warrants a Heritage Tree status and they are identified to be impacted by the I-5 Bridge Reconstruction Project.

Criteria Review – Significance of the trees

The two block area is heavily forested with the Barton-Noll Heritage Tree Grove #HT37. Inclusion of these 8 trees will enlarge the Barton-Noll Heritage Tree Grove. Pilots flying into Pearson Airpark often use this grove as a point of orientation. The trees are a neighborhood landmark and including them in the Barton-Noll Heritage Tree Grove would give them additional protection in the future.

Criteria Review – Condition of the trees

The grove is healthy, with few observable defects, disease or insects that significantly threaten them.

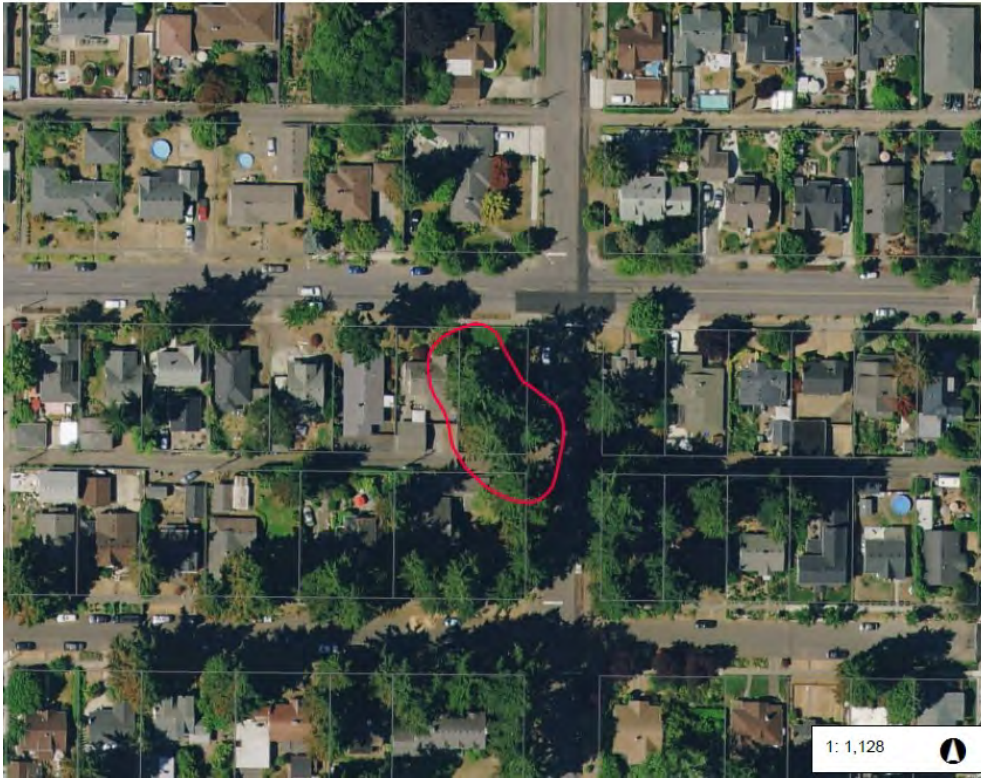
Maintenance Requirement

Trees have been well cared for, several would benefit from crown-cleaning though not absolutely necessary.

**Recommendation:** Approve the 8 Douglas Fir trees as Heritage Trees due to size and location.

Criteria Review – Significance of the trees

When the Cascade Park Community Library was designed in 2008-09 one of the first considerations was the existing trees. The neighbors were concerned about losing the existing trees with the new building. The Fort Vancouver Regional Library District wanted to be good stewards thus hired an arborist to evaluate the trees. The arborist estimated this tree was 90 years old at the time. The architects designed around this tree and it was preserved as part of the courtyard.

Criteria Review – Condition of the trees

The tree is in good/fair condition.

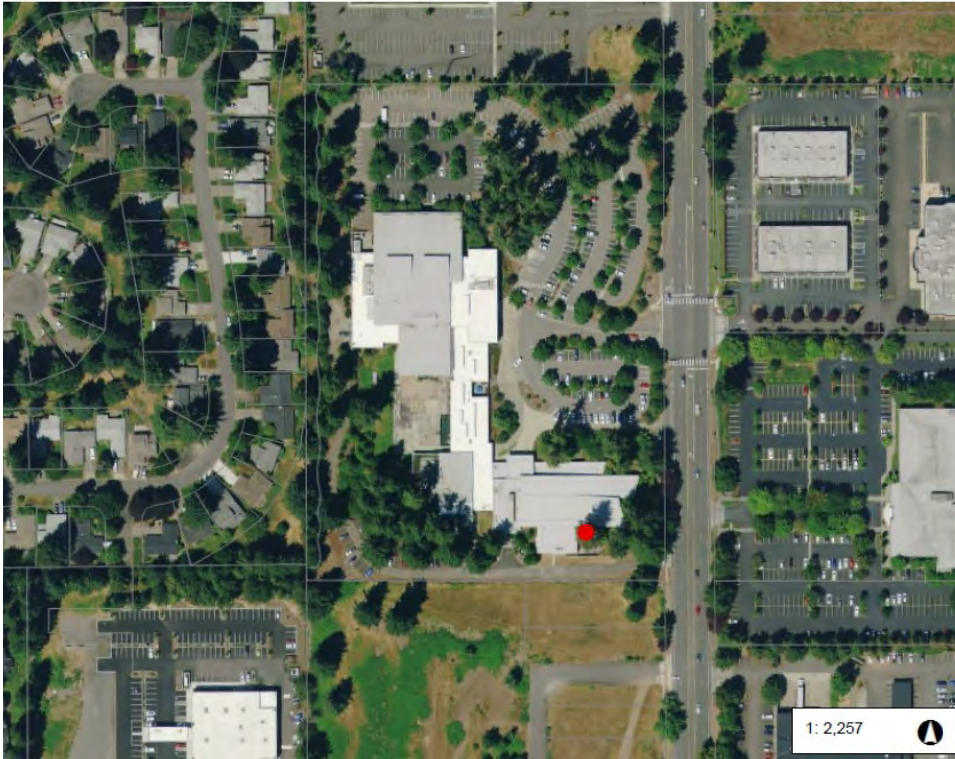
Maintenance Requirement

**Recommendation:** Approve the Douglas Fir tree as a Heritage Tree due to size, species, history and location.

The tree is in good condition with 4 stems.

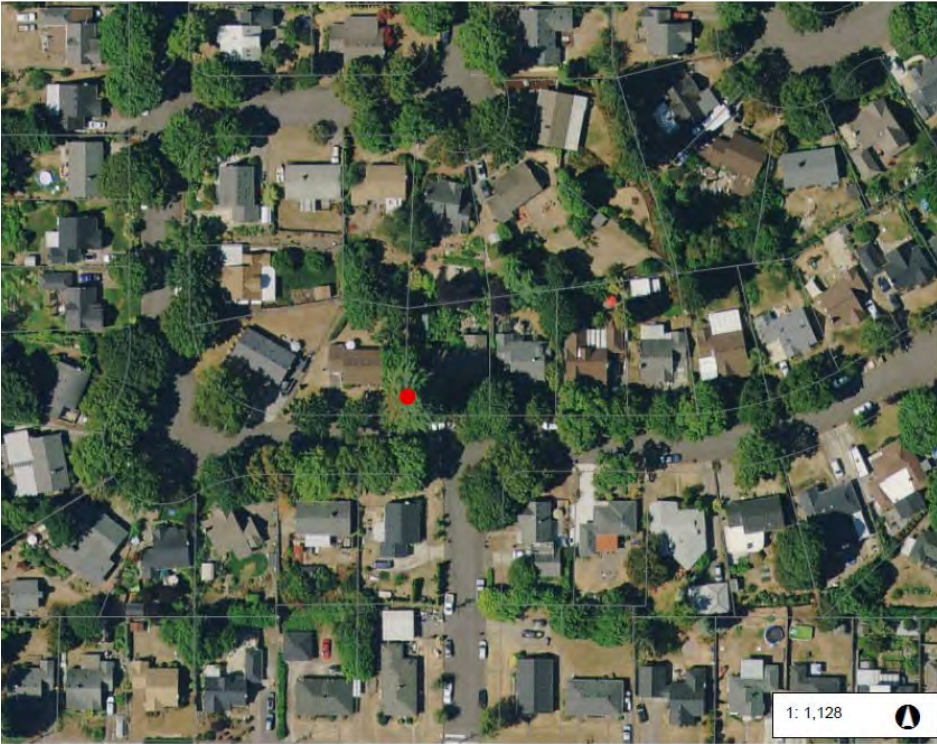
Maintenance Requirements

Big Leaf Maple Height-60', Spread- 80', Diameter-55"

Douglas Fir Height-80', Spread-50', Diameter-62"

Criteria Review – Significance of the trees

Two large mature native trees in the backyard providing shade and wildlife habitat. Both are distinctive for their size.

Criteria Review – Condition of the trees

Big Leaf Maple is in fair/poor condition, thinning with dieback. Douglas Fir is in good/fair condition which lost its top in the past.

Maintenance Requirements

Crown clean and prune for structure

**Recommendation:** Approve the Douglas Fir as a Heritage Tree due to size. Deny the Big Leaf Maple due to its condition.

### Criteria Review – Significance of the trees

When looking at aerial photos from 1950's, this was a large tree. The tree is of significant size, shape, age and adjacent to Washington St. Oregon White oaks are designated a priority species by Washington Department of Fish and Wildlife due to their habitat value.

### Criteria Review – Condition of the trees

The tree is in good/fair condition. Cavities are present likely due to the previous improper pruning years ago and storm damage.

### Maintenance Requirements

No maintenance is needed at this time.

**Recommendation:** Approve the Oregon White Oak as Heritage Tree due to its size.
