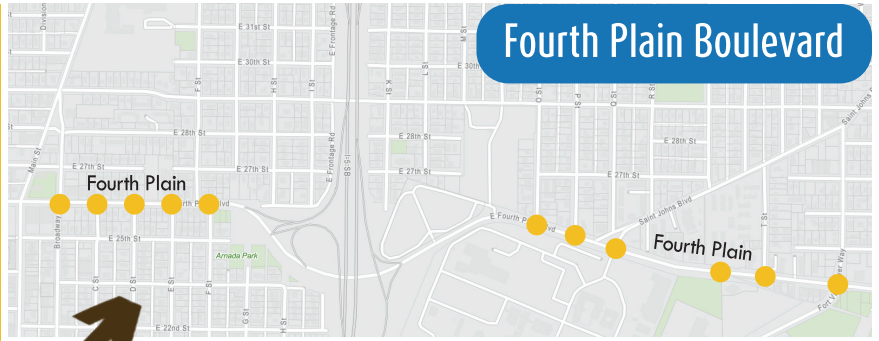


DEAR NEIGHBOR: The City of Vancouver will soon begin **upgrading curb ramps** for improved pedestrian accessibility, in keeping with current Americans with Disabilities Act (ADA), as part of the City's 2023 Pavement Management Program. This work is in advance of coming street pavement improvements in your neighborhood. Construction will occur along East Fourth Plain Boulevard and is anticipated to begin during April, with completion of the new ADA-compliant curb ramps expected by late June/early July, weather and construction conditions allowing. General work hours are 7 a.m. to 5 p.m., Mon. to Friday, but may be extended. Schedules can change.



ADA Standards are designed to protect and promote safe and accessible travel for all.

Please note: Federal law mandates that curb ramps be upgraded to current ADA standards along streets receiving treatments that are considered an alteration, such as paving or rehabilitation. In areas where ADA-compliant ramps exist, no changes are required.

COMING PAVEMENT WORK: Pavement resurfacing is planned for East Fourth Plain Boulevard, from Main Street to Fort Vancouver Way. Before this work, 30 curb ramps will be upgraded at various locations along the corridor including several signal upgrades.

Later this summer, City contractors will resurface East Fourth Plain, Fort Vancouver Way and East McLoughlin Blvd. See map for details: www.cityofvancouver.us/pavement. Contractors will grind off the existing surface of these streets and prepare them for paving. Vehicles will be able to drive slowly on the surface until the next stage. Paving, which involves a hot mix asphalt, will occur afterward. New street mobility elements will be implemented along East Fourth Plain Blvd. and Fort Vancouver Way after the paving work is completed. Community members have provided extensive input for this safety and mobility project.
