8. Urban Forestry Staff Report

Since the October Commission meeting, staff has been focused on next steps for the Heritage Trees Program, preparing for orientation of our two new staff, next steps with our Urban Forest Management Plan and our workload to ensure all aspects of our program are moving forward while one staff member is out on medical leave. Planting season is here and our fall contractor projects will start to be implemented in November. Staff hosted a successful Tree Giveaway Event on October 28th with 85 trees given away to homeowners. We planted trees at 3 homes were property owners needed assistance.

The Urban Forestry Management Plan was adopted by City Council on October 23, 2023. This is quite the achievement and thank you for all your hard work and dedication to see this through. Next steps will be to close out the project with our consultants and provide the final documents to the Department of Natural Resources. The Plan will also be rolled up into Comp Plan updates

this fall that Long Range Planning will be taking to Planning Commission and Council for updating.

Staff was preparing for our new staff which started their 1st day on Nov 6th by finalizing their work plans and preparing for their orientation.

Staff began drafting Vancouver's Tree City USA and Growth Award application which is due December 1st. We will be applying for the prestigious Growth Award for updating our Urban Forestry Management Plan, Pop Up Arboretums and the Old Apple Tree Festival.

Regarding the Federal IRA grant we were awarded this summer, staff will be meeting with the Federal IRA Grant representatives to begin to develop workforce development program around tree planting and maintenance. Staff will also be submitting a WA DNR Grant to complete a public tree inventory. This would support our proactive maintenance programs for street trees and park trees.

Urban Forestry is also partnering with Friends of Trees and working with Vancouver School District CTE (Career Technical Education) Program to host up to six high school students this fall in planting and maintenance projects.

Our site visit inspection backlog is approx. 20 days (goal is 10 day response time) and hovering around 35 requests. Development and inspection request are steady. Staff is completing final site inspections for all new development since June to ensure quality trees are planted per the approved tree plan.
