Since the March Commission meeting, staff has working on implementing our remaining winter planting projects, planning for Arbor Day, planning for our summer maintenance season, implementing our recent grant work, next steps with our Urban Forest Management Plan and our workload to ensure all aspects of our program are moving forward.

Earth Day

A collaboration of many community partners, this area features a statue of Mother Camas (designed and created by Native American artist) and native planting throughout the landscape island. Heritage Trees

Work continues on the most recent designated Heritage Trees. Staff has ordered the Heritage Tree signs, drafting the covenants that will be recorded as well as draft the update to the Heritage Tree Inventory.

Hazard and Invasive Assistance Program

We received our first applications for our new Hazard and Invasive Tree Assistance Program. Staff is currently meeting with our contractor and property owners to schedule the work. This new program is to support low-income property owners with hazard and invasive tree removal or pruning to help meet the City's equity and inclusion goals. Trees that are removed, will be replanting with quality trees. This program is funded through the City Tree Fund.

Emerald Ash Borer (EAB)

Our <u>EAB website</u> is up and includes our EAB Management Plan. We partnered with Clark Public Utilities to remove approx 80 ash trees along se 34th under powerlines. Outreach was conducted and we will be replanting this fall with utility friendly trees. We have contacted local wood recycling facilities and they will chip all ash logs. We are currently finalizing round 2 of treatment to preserve quality ash trees. We are planning for the removal/replacement of declining ash trees (approx 20 trees) and other action items. We are seeking funding from Washington Department of Natural Resources (DNR) to assist with implementation of our EAB management plan.

Staff is working closely with Pavement Management on 2024 Proactive Street Tree Management Program prior to paving season. Staff has been marking trees for pruning, removal and planting opportunities along the 2024 list of streets that will be serviced. Phase 2 streets have been notified and tree work has begun. Staff anticipate canvassing and inventorying the final Phase streets late April. We have been coordinating with Transportation staff, property owners and our tree contractor. Working with property owners, we will be developing planting plans for implementation this fall/winter. It is anticipated this new program will reduce storm damage in the right of way, address social/environmental justice, and improve climate resilience.

Our site visit inspection backlog is less than 14 days (goal is 10 day response time) and hovering around 20 requests. Development and inspection request are steady. Staff is completing final site inspections for all new development to ensure quality trees are planted per the approved tree plan.
