Final Plat – shall be prepared by surveyor licensed in the State of Washington and be in compliance with VMC 20.320 and include the following:

- Subdivision/Short Plat name
- PRJ/LUP/ENG application number
- Date
- Location including one-quarter (1/4) section, section, township, range and as applicable, donation land claim and/orsubdivision
- North arrow indicated
- Scale noted and shown graphically
- Heavy dashed line around the exterior boundary
- Boundary survey
- Lot, block and street right-of-way, street dedication and centerline dimensions
- · Lots numbered including lot squarefootage
- Surveyor title block on right lower edge on all sheets including the following:
 - Name of business/owner with the firm and/or surveyor and telephone number
 - o Sheet designation for multiple pages
- Identification of areas (tracts, wetlands, storm facilities, etc.) to be dedicated or reserved and state who willown/maintain
- Special setbacks
- Private/Utility easements
- Any conditions that need to be recorded with the plat or denoted on the face of the plat as indicated in the Planning Official's decision or Hearing Examiner's final order
- Roof downspout infiltration system (i.e., to street or individual system)
