I, the undersigned, do hereby acknowledge that this permit shall be posted in the vehicle(s) in such a manner as to be visible from the street and that it shall be used only on the dates noted below.

Should this permit expire and an extension has not been granted, all right to permitted recreational vehicle parking in the right-of-way shall lapse. Violation of this permit is a misdemeanor. An extension may be obtained for an additional seven (7) days. No permit shall be issued for a period of time in excess of fourteen (14) calendar days in any one calendar year.

I further certify that the recreational vehicle parking activity shall not unreasonably disturb or interfere with the safety, peace, comfort and repose of private property owners. I have read and agree to comply with all of the terms and conditions contained in the City of Vancouver Rules and Regulations on recreational vehicle parking, which I hereby acknowledge receipt of. I understand that noncompliance with any of these Rules or Regulations statutes/ordinances can result in the revocation of this Permit.

**RULES AND REGULATIONS ON**  
**RECREATIONAL VEHICLE PARKING**  
**IN THE CITY OF VANCOUVER**

1. Adequate sanitary facilities are provided and accessible at or near the proposed site, including for animals if allowed.
2. Adequate trash receptacles and trash collection are provided.
3. No electrical extension cords will cross the public area.
4. No animals may be tied up to the outside of a recreational vehicle.
5. The parking activity will not unreasonably disturb or interfere with the safety, peace, comfort, and repose of private property owners.
6. The permit shall be posted so as to be clearly visible from the exterior of the vehicle.
7. Compliance with all statutes and ordinances, rules and regulations is required.
8. Vehicle may not be closer than five feet to any driveway.
9. Vehicle may not be closer than fifteen feet to any fire hydrant.
10. Vehicle may not be closer than twenty feet to any intersection.
11. The City of Vancouver retains the right to require vehicle to be moved/removed.
