



## Zone 3A Residential Parking Permit Application

Please provide all information requested.

Incomplete or illegible application forms may not be processed.

Residential Parking Permits must be renewed twice a year, on or before June 30 and December 31, otherwise the permit will expire and be subject to citation(s).

Permit approval is contingent upon establishing a valid address and proof of residency. At application and renewal, residents must provide updated copies in person of all three of the following:

- Current Picture ID
- Proof of Residency (such as mail received at the address postmarked within the last 30 days or e-bills addressed to the current location and dated within the last 30 days)
- Copy of Current Vehicle Registration in Resident's Name\*

**Permits are only valid for vehicles registered in resident's name.** Permit holders are responsible for reporting any change in vehicle or license plate and providing current vehicle registration information.

Zone 3A permit holders may park their vehicle in Zone 3A at any legal parking space signed for 2 hour parking; all on-street parking is subject to Section 19.12.100 Prolonged Parking. (see attached map)

\*Per WA state law, **RCW 46.16A.140**, new residents have 30 days to register their vehicles.

This application form does not constitute any agreement for parking services until this application is processed by the City of Vancouver and a parking permit is issued.

I have received and understand the City of Vancouver Parking Services Terms and Conditions and Parking Rules and Responsibilities. I agree to abide by the On Street Terms and Conditions and Rules and Responsibilities.

I understand that the On Street Terms and Conditions and Rules and Responsibilities are subject to change without prior notice, and if I don't agree to the changes I must notify Parking Services and forfeit my parking permit privileges.

I understand that I must:

- Renew the permit before it expires (twice a year, before June 30 and December 31), according to the Terms and Conditions. Failure to do so may result in citation(s) being issued.
- Display my permit on the inside of the driver's side of the windshield of my vehicle, completely in view, but not to obstruct the driver's clear view of the road, per RCW 46.37.410.

I understand that all on-street parking is subject to **Section 19.12.100 Prolonged Parking** and that during special events, vehicles left on the street are subject to tow and impoundment.

I understand that misuse of any parking permit may result in a citation for improper parking and infractions may result in suspension of any parking permit.

I understand that currently there is no fee, but this is subject to change; fees may apply over time.

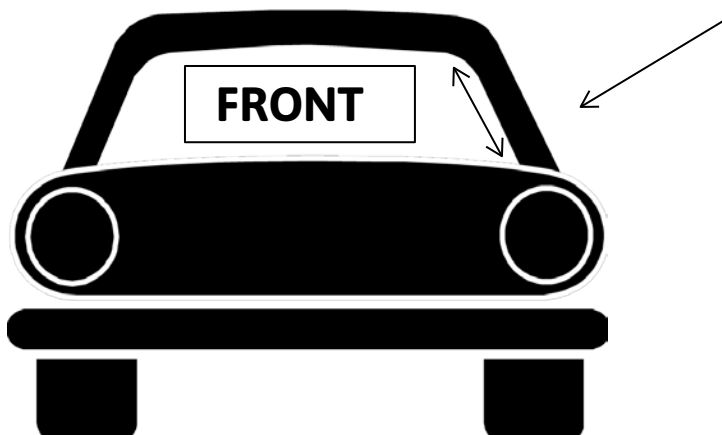
I understand that I as a Zone 3A Resident, I may apply for a temporary visitor's permit for any person visiting my home.

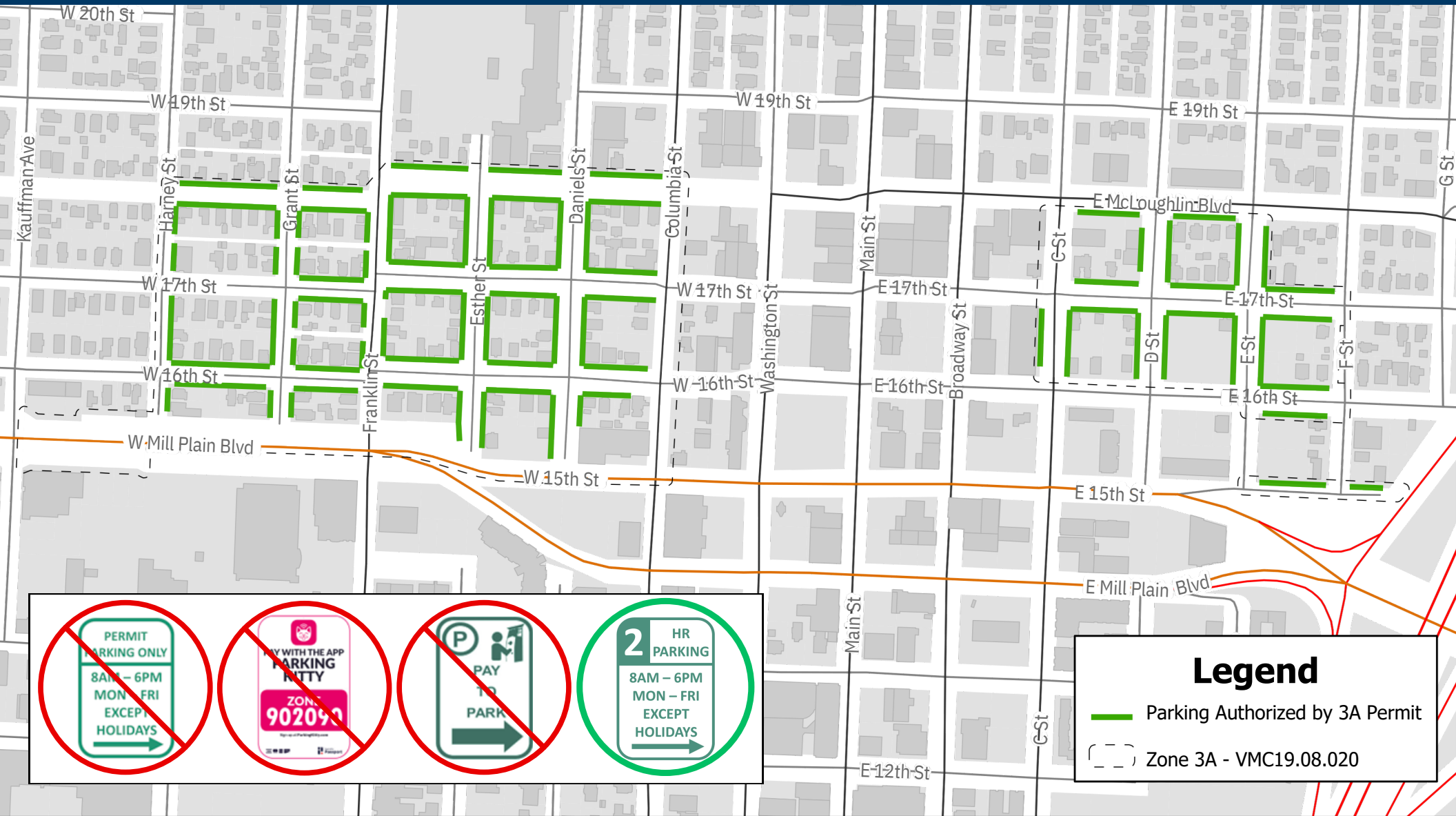
Permit must be displayed on the inside of the driver's side front windshield, in a manner so as to not obstruct vision per RCW 46.37.410.

Failure to display the permit as required could result in citation(s) or impoundment of the vehicle.

Vehicle must be registered to permit holder and on file with Parking Services.
